The 2025 BTC Junior Tennis Clinics will be offered by Kane Easter Tennis at the Bowmanville Tennis Club Courts. Clinic Sessions will be offered on Tuesdays and Thursdays.

### **JULY AND AUGUST SESSIONS**

- Clinic A – Tuesdays 4:00 – 4:55
- Clinic B – Tuesdays – 5:00 – 5:55
- Clinic C – Thursdays – 4:00 – 4:55
- Clinic D – Thursdays – 5:00 – 5:55

Each clinic costs \$185.00 (HST included) and includes 7 sessions (2 rainout dates). Sessions are 55 minutes to allow for safe entry and exit of the courts. Clinics will run for 7 weeks from their start date. The maximum number of participants allowed in each clinic will be 6. A minimum of 4 participants is required for a clinic to run. Please note that Kane will try to accommodate clinic preferences, but it may be necessary to combine clinics depending on numbers and/or prior experience. You do not have to be a member of the BTC to take a clinic, however, those who are not members will only be able to utilize the courts during clinic time. (BE – Beginner – IN – Intermediate – AD – Advanced) Kane will contact parents as to the Clinic arrangements. **The BTC will not be collecting fees, Kane will do so once the clinics are confirmed.**
